Competition: Terms & Conditions of Entry: Careers Fest Pepsi winter warmer check-in prize draw

Information on prizes and how to enter form part of these Terms and Conditions of Entry ("the Conditions").

By entering this Promotion, all Entrants will be deemed to have accepted and agreed to be bound by these terms and conditions.

The Terms and Conditions of this Promotion are governed by the laws of the State of Victoria.

Entry to the Promotion is open to all current Higher Education Federation University students at the time of entry into the Promotion. The judging will be conducted by Student Engagement at Federation University's Mount Helen Campus 12pm AEST 1 August 2025. A random number generator on an Excel spreadsheet will be used to pick the Winning Entrants.

The winning entrants and the 'winning entries' will be the ones drawn randomly first and in succession. The winning Entrants will be notified within 2-3 business days of the competition closing date. Winning Entrants will be announced on the official Federation University Australia "Feduni Current Student" Meta page/s and/or Student Newsletter/specific webpage within 5 business days. The Winning Entrants will be contacted through their Federation University student email with details on how to claim their prize. Student Engagement team's decision is final and no correspondence will be entered into.



To enter, Entrants must scan the check-in form QR code at the Careers Fest event, enter their Federation University student ID in the form and submit the form within the competition timelines.
