

Promotion Terms & Conditions – GAME OF CHANCE

Competition: Women of Colour in STEM Awards - Lucky Draw

Terms & Conditions of Entry:

Information on prizes and how to enter form part of these Terms and Conditions of Entry (“the Conditions”).

By entering this Promotion, all Entrants will be deemed to have accepted and agreed to be bound by these terms and conditions.

The Terms and Conditions of this Promotion are governed by the laws of the State of Victoria.

Entry to the Promotion is open to all current Institute of Innovation, Science and Sustainability (IISS) students who identify as a woman of colour at the time of entry into the Promotion. Employees and immediate family members of the Promoter and/or any agencies associated with this Promotion are ineligible for entry. Entrants under 18 years of age must have parental and/or guardian approval to enter and it is the Entrant’s responsibility to ensure that the parent and/or guardian of the Entrant has read and consented to these Terms and Conditions.

This Promotion is a game of chance. Each winning entry will be drawn randomly. The Promoter accepts no responsibility for late, lost or misdirected entries.

Promotion commences 9am AEST on 1 September 2025. Promotion closes 5pm AEST on 22 September 2025 (the Promotion Period).

Only one (1) entry per Entrant is permitted. Any subsequent entry after the first valid entry is received will be deemed invalid. Entries are deemed to be received at the time of receipt by the date received on Federation University Australia Microsoft 365 Event Registration Portal and NOT at the time of transmission by the Entrant.

The judging will be conducted by a professional panel at Federation University’s Melbourne City Campus between 9-10am AEST on 25 September 2025. The winning entrant and the ‘winning entries’ will be the ones drawn randomly first and in succession, by the judges (two in total) at Federation University’s CLXO Office. The winning Entrants will be notified within 2-3 business days of the competition closing date. Winning Entrants will be announced on the official Federation University Australia “Feduni Current Student” Meta page(s) and/or Student Newsletter and/or specific webpage within 5 business days. The Judges' decision is final and no correspondence will be entered into.

If a winning Entrant cannot be contacted or is unable to attend the Women of Colour in STEM Awards event for any reason, they must notify the Promoter within 24 hours of being notified of their win. In such cases, the Promoter reserves the right to conduct a

redraw to allocate the prize to another eligible Entrant. The redraw will be conducted in accordance with the original draw procedure, and the new winner will be notified as soon as practicable.

To enter, Entrants must register their interest via the Federation University Event Registration Portal by completing a registration form for event “Lucky Draw: Win your way to the Women of Colour in STEM Awards” within the competition timelines.

The first and second complete entries randomly selected will each receive an invitation to attend the Women of Colour in STEM Awards event valued at \$269 each.

Total prize pool value is up to AUD \$538RRP incl. GST. The Promoter accepts no responsibility for any variation in the prize value. Prizes, or any unused portion of a prize, are non-transferable or exchangeable and cannot be taken as cash. In the event that a prize, or an element of a prize, is/are not available, the Promoter reserves the right to substitute prize(s) in its discretion to the same and equal recommended retail value and/or specification subject to any written directions from the various lottery Departments.
