Important information

- > Course fees are indicative only and total fees will depend on student eligibility for government funding and the combination of units selected to meet course requirements.
- > Students may also be required to pay Material Fees which cannot be deferred to a VET Student Loan and are not included in the total course tuition fees above.
- > Students undertaking a course on a full-fee basis will incur a 20% loan fee for each unit of study that is deferred to a VET Student Loan.
- > Diploma and Advanced Diploma tuiition fees are not eligible for concession rates
- > Aboriginal or Torres Strait Islander students will have access to free tuition for approved training, including Diploma/Advanced Diploma under the Victorian Government's Skills First Aboriginal Access fee waiver initiative
